## Our Commitment to Your Privacy

We built [approvedsuppliernetwork.com](http://approvedsuppliernetwork.com) to make it easier to share Approved Supplier information with your Customers. We understand you may not want every business to have the information you share on [approvedsuppliernetwork.com](http://approvedsuppliernetwork.com); that is why we give you control of your information. Our default privacy settings limit information such as Approved Supplier Documents to those who you have confirmed the Customer status with your business. You can also control the availability of your business details through the Supplier Search mechanism.

## The Information We Collect

When you visit [approvedsuppliernetwork.com](http://approvedsuppliernetwork.com), you provide us with two types of information: personal and commercial information you knowingly choose to disclose that is collected by us, and web site use information collected by us as you interact with our web site. When you register with [approvedsuppliernetwork.com](http://approvedsuppliernetwork.com), you provide us with certain business information such as contact details and business summaries.

When you enter [approvedsuppliernetwork.com](http://approvedsuppliernetwork.com), we collect your browser type and IP address. This information is gathered for all [approvedsuppliernetwork.com](http://approvedsuppliernetwork.com) visitors. In addition, we store certain information from your browser using "cookies." A cookie is a piece of data stored on the user's computer tied to information about the user. We use session ID cookies to confirm that users are logged in. These cookies terminate once the user closes the browser. By default, we use a persistent cookie that stores your login ID (but not your password) to make it easier for you to login when you come back to [approvedsuppliernetwork.com](http://approvedsuppliernetwork.com). You can remove or block this cookie using the settings in your browser if you want to disable this convenience feature.

You post User content (as defined in the [approvedsuppliernetwork.com Terms of Use](https://www.approvedsuppliernetwork.com/terms-of-use)) on the Site at your own risk.
